## REAL ESTATE INVESTING SUMMER SCHOOL

You will receive an intensive, 12-Course education over about 12 weeks. You will receive 18 hours of recorded educational materials and homework to complete prior to class. You will then meet for 2.5 hours, twice a month over a three-month period for a total of 6 live classes. The syllabus and schedule will be released 4-6 weeks before the first class. ## **SYLLABUS**

**Course 1: Real Estate Contracting:** Basic contracting principals, the RE purchase contract, the Utah REPC, earnest money & disputes, creating addenda & making changes, canceling the contract, breaches of contract and preparing to enforce it.

Course 2: Beginning Wholesaling: The wholesaling contract, assigning Utah REPC, assignment addendum, making changes, assignment fee, closing tips, buyer breach, seller breach, licensing and other tax/legal issues.

Workshop: Exercises in creating and modifying real estate contracts for purchase and wholesale.

**Course 3: Advanced Wholesaling:** Using a trust to wholesale, using a disposable LLC to wholesale, wholetailing, other advanced wholesaling techniques and issues.

Workshop: Exercises in creating wholesaling documents.

**Course 4: Beginning Asset Protection:** Personal & Professional liabilities, corporate and charging order protections, the LLC as a protection tool, adding privacy, maintaining your protection for the long haul.

**Course 5: Intro to Seller Financing:** Overview of seller financing deals, contracts for deed & lease options, pros and cons, analysis and legal issues.

**Course 6: Three Ways to Seller Finance a Deal:** True seller financing, the all-inclusive & the subject-to deal, best practices and 30 tips to do it right.

Workshop: Exercises in creating seller financing documents.

**Course 7: Lease Options:** LOs from the buyer's side, from the seller's side, lease sandwich, the master lease, the option, exercising and assigning the option, hurdles and solutions in exit strategy.

**Course 8: Advanced Asset Protection Strategies:** The Series LLC, asset holding trusts, the family limited partnership, the "property management" deflection strategy, equity stripping, "self" partnering.

**Course 9: Private and Hard Money Loans**: Private lending, the note and deed, understanding a title report, recording position, other types of notes and deeds, notice of interest, foreclosing, deed in lieu.

Workshop: Exercises in creating loan documents & lease options.

**Course 10: Holding Real Estate:** Holding title, deeds of conveyance, clouds, leasing, other rental documents, security deposits, evictions, pets & disabilities, Section 8 housing, insurance, avoiding and preparing for the eventual lawsuit.

**Course 11: Flipping Real Estate:** Taxation of flips, liability & insurance, contractor agreements, working with subs, mechanic's liens, releases, Utah state construction registry, the scope of work and making changes.

Course 12: Final Issues in Real Estate: Bankruptcy, probates, title insurance, partnering, self-direction, raising capital, other legal issues.

**BONUS COURSE: Seller Financing Financing**: An in-depth exploration of the numbers behind complex seller-financing deals.
